II. Community transformation for a more sustainable community.

We have heard this desire from the SuSo Council and community in general, to make our community BETTER than it was before the pandemic. We are looking for ways forward that are consistent with SuSo values of finding sustainable community through advancing equity, economy, and environment.

The **DRAFT** prospectus you reviewed (below) is very much under construction with business and equity leaders. The scope currently is to seek support from individuals who live in Sonoma Valley or have personal connections here, to build momentum for bigger investments in the future, in SV and SuSo.

Main objectives in the prospectus, for discussion:

- Support small local businesses.
- Safety net, basic support for SV's people and households, which overlaps with housing strategies

III. Discussion

Are you comfortable with moving forward in <u>exploratory</u> conversations about the draft content and ideas in the prospectus, with various community stakeholders and potential donors?

Much discussion about local currency which is 1 possible item in the prospectus that is not proposed for direct near-term action. Many communities have developed a locally administered currency that fosters local community investment. Can be exchanged for \$US. Caitlin: An unsolidified idea.

Mark: Likes concept of local currency but not supported by federal law, must be informal. Red flag, couldn't pay wages with it. More of a fun concept. Point Reyes Station has it?

Aiko-Sofie: See Ying, founded by Carla Ballerd (alternative to local currency). Self-reliant community concept.

Logan: Let's be realistic. Local currency is not realistic for supporting working people. Not realistic to do basic income with philanthropic money. Start with how much money SuSo thinks it can raise. Remember massive government budget shortfalls. Fred: Supports local currency as it might enable us to pay essential workers a living wage. Might be a way to act on desire for an equitable future. Need to continue to transcend silos.

Lauren: It is clear that there are people in this community both with and without a lot of money. It's about getting back to business as usual, at least initially, a new normal. Some industries and individuals that are booming. Supports a way to harness and distribute locally.

Ann: We need creative ways to get money circulating again. What are the specific products? Likes "buying iconic buildings" and "land trust" ideas.

Acting now for a more sustainable Sonoma Valley



A period of uncertainty, yet the time for action is upon us all.



The Covid-19 pandemic will leave a lasting impact on **our economy** and **our society**. Severe unemployment, heightened family stress, permanent loss of many local businesses, school closures, and widespread housing insecurity are just some of the short-term impacts of this crisis.



Strains on our natural environment continue while we cope with the pandemic. Local stresses include recurring climate change disasters such as wildfires, floods, heat waves, and groundwater failures.



Choices we make now can transform our communities into more connected, equitable and caring places, positioning Sonoma Valley for long-term sustainability for our people, our economy, and our environment. We can build a model for others to emulate.



Local creativity, civic partnerships and strategic capital expenditures are needed to forge a long-term path toward stability in the wake of the Covid-19 pandemic.



Recovery or transformation?

Disaster recovery efforts typically focus on returning to business as usual, seeking to reclaim what has been lost. But getting back onto the same course of action that brought us where we are today is at odds with creating more sustainable communities. what if we can instead move in a new direction,

not going back but headed forward toward a future aligned with sustainable values: equity, caring, and stewardship?

True transformation requires thinking and acting differently about our future.



In many places, recovery efforts will run up against inherent conflicts and partisan differences that will hamstring new actions, exacerbate existing inequalities, and heighten inter-sector tensions. Re table 1: Creating a system that supports the infrastructure that can in turn support individuals. What if we have a fire and power outage while we're still sheltering in place?

Re table 2: It's like a shock-absorber. The create a springy, resilient economy that isn't too stuck in its ways to bounce back in effective, efficient ways.

When it comes to housing, I think a lot of people currently taking up valuable rental properties are interested in buying homes. If more of the local community was able to buy homes that are now being used as second homes or quickly snatched up by people

from outside our community with cash offers, it would free up some much needed rental space that could help balance the price being charged for said rental properties. When walking around Sonoma neighborhoods during this time of quarantine, I am always surprised by how many homes there are but how many appear vacant. If our mission is to keep green space and don't really want to see it disappearing for low-income housing developments (as much as they are needed), what can be done with what we already have existing in the market already?

Fred Allebach via email, excerpt only:

I think adjustments need to be made ...to ... sew the threads between "sectors", i.e. the working class and Latino populations, the wealthy, and the business and environmental communities... For SuSo this means including some actual, fire breathing POC advocates: NBOP (Belen Grady), Food For All (MariCarmen and Maite can maybe be bridges between SuSo/ La Luz/ non-profits and Food For All leaders), SoCo United in Crisis and North Bay Jobs with Justice (Mara Ventura) in discussions about what positive transformation means from an equity standpoint. We probably don't want to simply and tacitly recap past inequities as we imagine a positive future.

no one making working class money can shop in Sonoma. Suggestion: get a public bank to fund, or a rich donor to buy a building where there's a food store space and space for workers to live. It strikes me that SuSo until now has been very measured and cautious. It may be time to step out and make your voice heard,

SuSo needs to get strongly behind lobbying for public banking. Contact Chris Petlock on this.

Ellie Insley, advisor, via email, excerpt only:

"each time I read the part about "iconic businesses" and "desirable businesses" the idea sounds exclusive. Maybe have a hierarchy of criteria not requiring all.

the document feels incomplete without the Environmental third leg of the stool, especially if jobs could be generated and the triple bottom line achieved, such as:

- 1. Retrofit 80% of existing homes to reduce emissions, improve indoor air quality, address inequities in housing, and reduce health costs.
- 2. Increase soil health and soil carbon in agriculture and wildlands by implementing proven practices such as biochar, composting, and reduced tillage.
- 3. Build microgrids in select locations powered by renewables, to increase self-sufficiency, improve air quality, reduce health costs, and reduce emissions (and create jobs El).
- 4. Increase health and resilience of wild and rural residential areas (80% of SV) to achieve multiple objectives of water retention, wildlife habitat, youth and low-skill employment, property value, and fire risk reduction. Activities include erosion repair, forest thinning where appropriate, dispersed water capture, de-ditching, prescribed fire, invasive weed management, and reconfiguration of wildlife-blocking fences.

Input on draft Forward Not Back, received after Council meeting

You all have done a lot of work coalescing ideas/concepts and I am glad to see the draft. Some thoughts;

Names- in reviewing the words that came up two themes stood out for me- balance (equity, diversity) and forward. Lots of the words used as a single aspiration are very often perceived as "PC", which we might want to be sensitive to in the name so it does not get categorized before it even starts. One possibility: Valley Forward.

Question- when reading the report, I kept wondering what additional data is there on housing. So what's the status of the long awaited report?

If we really want to do something that others cannot, what about focusing on SDC redevelopment and driving that the way it needs to go to benefit everyone? I know I keep asking that, but it really is THE project that could reshape the valley for decades to come. Yet SuSo does not seem to directly engage on it. Yes Richard is very involved, and others in SuSo, but it needs much more focus from the broader community. So many folks (esp. those in Sonoma town) think its a "Glen Ellen thing." It's not and the sooner the broader valley engages with it the better. It could help achieve several key elements in this draft document.

Since you are expanding the council, I am hoping you might bring in more small biz voices in some way (since that is a hard hit group now - beyond the chamber?) and then someone from the Glen Ellen Forum.
